- The speed limit after entering the front gate is 5 miles per hour at all times. At any time a horse could be loose on the property or a boarder may be riding and you will be held responsible for any injury due to your negligence. If we repeatedly have to ask you to slow down you will not be permitted to continue lessons at Criswood.
- There is no smoking permitted while on the property. If you are smoking in your car you will be asked to leave.
- There are no dogs permitted on the property for any reason. If you bring a dog you will be asked to leave.
- Due to safety reasons there is no wandering permitted on the property. You are to meet your instructor at the designated area and not enter the barn without permission.
- **I will allow you to make up two lessons per 8 week session due to illness.** You must give me at least four hours notice to be able to make up your lesson. If you do not give me adequate notice you will forfeit your lesson.
- During the winter months lessons will be canceled if Prince William County Schools are closed.
- All students are required to have approved riding helmets and boots. Bicycle helmets are not permitted.
